CALL FOR ABSTRACTS FOR POSTER PRESENTATIONS

Theme: "Developing Healthy Communities through Advocacy, Collaboration, Education, Leadership, Research, and Service"

WHO SHOULD SUBMIT AN ABSTRACT

Graduate and Beta Chapter members are being called to share innovative programs and/or projects and technological advances related to the Boule' theme via poster presentations.

POSTER PRESENTATION OBJECTIVES

- A. To provide a snapshot of the projects/activities of the membership.
- B. To increase knowledge, promote collaboration/partnerships, and demonstrate the quality of work performed by the membership in "Service for Humanity".

CATEGORY OF FOCUS

Abstracts may be submitted related to programs or projects that focus on innovation and technological advances in the following categories:

- A. Advocacy/Legislative Action
- B. Collaboration/Partnerships
- C. Advances in Education (Initial or Continuing)
- D. Leadership Initiatives
- E. Emerging Technologies
- F. Health Promotion and Disease Prevention
- G. Member Engagement and Retention

GUIDELINES FOR THE ABSTRACT FOR A POSTER PRESENTATION

Font: Times New Roman, 12 Point

Title: Should be brief and concise (limited to 15 words)
Keywords or phrases: Three words that relate to the topic, practice setting, and/or target audience should be written under title
Abstract: a maximum of 200 words.

ATTACHMENTS TO THE ABSTRACT:

- A. A cover sheet with the title of the poster, author(s) name (s), email address, and credentials; chapter, and region; (Do not put on the abstract). Beta members should list their credential as "SN".
- B. For continuing education purposes, please complete the Education Planning Table, the Conflict of Interest Disclosure Form, and Commercial Support Statement. (Continuing Education credit will be awarded for attendance at Poster Presentation Session).
- C. Abstract Summary should provide a brief description of the educational activity. This should be a short (max. of 50 words) compelling description of the abstract that describes what participants should expect by viewing the poster. This abstract summary will be used in written publications to attract conference attendees.
- D. References: At least 3 current references should be listed in APA format. These references may be listed on the poster or on a handout related to poster.

DEADLINES

The deadline to submit a Poster Abstract is February 1, 2019. A notice of confirmation of receipt of abstract will be sent when poster abstract is received. Abstracts are to be sent via email via the following link: CEPabstracts@gmail.com

The Poster Review Committee will review all submissions and notify selected poster presenters no later than May 1, 2019.

Upon notification of acceptance of the abstract for Poster Presentation, the author must submit an "intent to present" notice no later than May 15, 2019 and register for the conference. Final abstract acceptance will be conditional upon conference registration. To present, you must be a registered conference attendee.

EVALUATION CRITERIA

Abstracts will be evaluated based on:

- A. Presentation: grammar, spelling, punctuation, and clarity
- B. Content: substantive, current, of interest to potential attendees; provides a logical discussion, with substantial details, supporting the overall topic.
- A. Relevance: relevant to the nursing profession according to the category selected and consistent with the conference theme and objectives
- B. Outcomes: demonstrates actual outcomes or a plan for evaluating potential outcomes

POSTER PRESENTER REQUIREMENTS

- A. Posters are limited to a maximum size of 3 feet tall by 4 feet wide (36"X48").
- B. Presenters will be required to submit all necessary forms by the deadlines provided in the acceptance letter.
- C. Presenters will be responsible for setup and breakdown of their poster at the identified times and being present with their poster during identified "poster viewing periods"
- D. Presenters are responsible for all costs associated with preparing poster presentation, registering for Boule' and all associated travel and accommodations.
- E. The standard format for the poster will be sent to presenting author(s) upon acceptance of poster for presentation. All poster presenters are expected to comply with the standard format.
- F. If more than one author is presenting the poster, the first listed author is considered the primary author and will receive all correspondence. It is primary author's responsibility to communicate with the other author(s).

NATIONAL SECRETARY

Greetings, wishing each of you and your family a wonderful holiday season. Please see this abbreviated version of the National Secretary's Booklet 2018-2019; to help guide you with the numerous reports for our organization.

• Chapter Statement

The Chapter Epistoleus and Tamias should collaborate before sending. Remember the Chapter Basileus must sign the form. Postal mail dues, also referred to a per captia tax (pct.), using a Chapter check, (except if you are a Member-At-Large) to the National Tamiochus. Include the "Chapter Statement" form in the envelope. Postmarked before the May 1st deadline. Chapter statements postmarked after May 1st are assessed a late fee per member; this does not apply to life members. Postal mail to the National Tamiochus, Erica Underdown Palmer. Next, EMAIL a copy of both the check and the Chapter Statement to the National Secretary and Headquarters. This step is extremely important!

National Officers', National Committee Chairmen & Regional Directors' Reports

National and Appointed Officers, National Committee Chairs, and Regional Directors are to submit the above listed reports annually on **May 15th**. **Email** the report to the National Secretary to ensure uniform formatting. The **National Secretary will forward to Headquarters**.

• Chapter Officer's Report

The Chapter Basileus shall submit the "Chapter Officer's Report" annually on **May 30th** each year. If the Basileus is going out of office, the report should be submitted by the outgoing Basileus. Compose a list of each elected officer including the Immediate Past Basileus. Email report to: National Secretary, Headquarters, Regional Director, First Supreme Anti-Basileus and the National Dean of Membership

• Chapter/Boule Report

The Chapter Basileus shall submit this report annually on May 30th. If the Basileus is going out of officer, the report should be submitted by the outgoing Basileus. Email the report directly to Headquarters.

• Boule Credentials Report

Boule Credentials Report is due **June 18, 2019.** Email the report directly to the National Secretary; CHSNia@outlook.com.

• Chapter Roster Directory

Compose a Chapter Roster for the entire Chapter. The roster, referred to as the Excel® spreadsheet is located on the website. DO NOT ALTER the format of the spreadsheet. Each piece of data must be in a separate column, for example address, city, state, and zip is just one example. Use normal case letters, e.g. Mary **Jones.** Submitting the spreadsheet ensures the membership receives publications from Chi Eta Phi Sorority, Incorporated. Chapter rosters not received by the deadline will result in Chapters not being included in the National Directory. In addition, members may not receive the Glowing Lamp or JOCEPS, and will not have access to the "Members Only" section of the website. The deadline for all roster submissions is **June 30th** of each year. Submit completed information as outlined on the form and email to:

Email the Excel Roster/Directory to three (3) entities:

- National Secretary CHSNia@outlook.com
- National Headquarters chietaphi@verizon.net
- Regional Director or whomever the Director designates

NOTE: Postal mailed Excel Spreadsheet will be not be accepted, nor will copies in Word© or pdfs.

Reactivation

When a member reactivates; the member pays National, Regional, and Local dues directly to the Chapter.

• Replacement Cards

For replacement member cards, type the name of the member as it should appear on the card using the "Membership Card Only Roster." This form must be completed in ALL CAPS. Use the purchase order (PO) form to request membership card(s). Postal mail the PO and Chapter check to National Tamiochus; followed by emailing the same information to Headquarters and the National Secretary.

Transfers

The National Secretary approves all "Transfer" requests, except when a member is requesting to become a Member-At-Large. The first step is to contact the Basileus of one's current Chapter to begin the transfer process. If unable to obtain verification from the current Chapter in which the member was last active, contact the National Secretary. If a member is requesting to transfer from a Chapter to "Member-at-Large" status, the same form needs to be completed to verify membership

with approval from the Chapter Basileus and the Regional Director, followed by approval from the National Secretary. The member wishing to transfer to "Members-at-Large status must live at least 50 miles away from a graduate chapter.

• Intake

Please refer to directions in the service letters from the National Dean of Membership and the National Tamiochus to ensure compliance during the Intake Process. Postal mail the purchase order and check to the National Tamiochus. Initial joining fees must be paid in full prior to Induction.

Next, email copies of PO and all forms related to Intake to the National Secretary and Headquarters. Allow 10 to 14 days from the time the email is received for your order to be processed. There will be delays if the order is not legible, incomplete, or missing forms. Orders that include sorority pins are insured and must be signed for; therefore, please make sure the name and address for the person receiving the package is correct on the purchase order. When submitting the "Membership Certificates" form, you must list the city of the chapter Charter location, NOT your personal address.

- 1. Bylaws notebook
- 2. Bylaws (new members)
- 3. History Book I (1932-1967)
- 4. Membership Card
- 5. Sorority Pin
- 6. Application Fee
- 7. Ritual Book

WALK/RUN AND VIRTUAL TOUR TO END CHILDHOOD CANCER



Many of the children are diagnosed with Cancer, Sickle Cell Anemia, HIV/Aids and other chronic diseases. 
